

No. PAP/Legis-2(46)/2025/397. The Provincial Motor Vehicles (Amendment) Bill 2025, having been passed by the Provincial Assembly of the Punjab on May 21, 2025, and assented to by the Governor of the Punjab on May 29, 2025, is hereby published as an Act of the Provincial Assembly of the Punjab.

THE PROVINCIAL MOTOR VEHICLES (SECOND AMENDMENT) ACT 2025

ACT XXXIII OF 2025

[First published, after having received the assent of the Governor of the Punjab, in the Gazette of the Punjab (Extraordinary) dated May 29, 2025.]

Act

further to amend the Provincial Motor Vehicles Ordinance, 1965.

It is necessary further to amend the Provincial Motor Vehicles Ordinance, 1965 (XIX of 1965) for the purposes hereinafter appearing.

Be it enacted by Provincial Assembly of the Punjab as follows:

1. Short title and commencement.— (1) This Act may be cited as the Provincial Motor Vehicles (Second Amendment) Act 2025.

(2) It shall come into force at once.

2. Amendment of section 39-A of Ordinance XIX of 1965.— In the Provincial Motor Vehicles Ordinance, 1965 (XIX of 1965), for brevity referred to as 'the Ordinance', in section 39-A:

- in the heading, after the word "cars", the words "and motor cycles" shall be inserted;
- in sub-section (1), after the word "car", the words "and motor cycle" shall be inserted;
- in sub-section (2), for the word "Fifteen", the word "Fifteenth" shall be substituted; and
- in sub-section (3), after the word "vehicle", the words "and motor cycle" shall be inserted.

3. Amendment of section 107 of Ordinance XIX of 1965.— In the Ordinance, in section 107, for the expression "fine which may extend to one hundred rupees, and if having been previously convicted of such an offence, shall again be guilty of an offence under this section, shall be subject for every such subsequent offence to fine which may extend to five hundred rupees", the following shall be substituted:

"imprisonment for a term which may extend to one month, or with fine as given below or with both:

Category of goods vehicle	Fine, in case of first offence	Fine, if offence is repeated within one month from the date of commission of the first offence
(a) goods vehicle with two axles	(i) Rs. 2,000 for overloading up to 10%. (ii) Rs. 5,000 for overloading exceeding 10% and up to 30%. (iii) Rs. 7,000 for overloading exceeding 30%.	(i) Rs. 4,000 for overloading up to 10%. (ii) Rs. 10,000 for overloading exceeding 10% and up to 30%. (iii) Rs. 14,000 for overloading exceeding 30%.
(b) goods vehicle with three or four axles	(i) Rs. 6,000 for overloading up to 10%. (ii) Rs. 10,000 for overloading exceeding 10% and up to 30%. (iii) Rs. 20,000 for overloading exceeding 30%.	(i) Rs. 10,000 for overloading up to 10%. (ii) Rs. 20,000 for overloading exceeding 10% and up to 30%. (iii) Rs. 35,000 for overloading exceeding 30%.
(c) goods vehicle with more than four axles	(i) Rs. 7,000 for overloading up to 10%. (ii) Rs. 15,000 for overloading from 11% to 30%. (iii) Rs. 25,000 for overloading exceeding 30%.	(i) Rs. 12,000 for overloading up to 10%. (ii) Rs. 25,000 for overloading exceeding 10% and up to 30%. (iii) Rs. 40,000 for overloading exceeding 30%.

4. Amendment of section 112 of Ordinance XIX of 1965.— In the Ordinance, in section 112:

- for the words "two hundred" and "one thousand", the words "one thousand" and "ten thousand" shall be substituted respectively; and
- for the words "five hundred", appearing twice, the words "five thousand" shall be substituted.

5. Amendment of section 112-C of Ordinance XIX of 1965.— In the Ordinance, in section 112-C, in sub-section (1):

- the words "trailer or" wherever appearing shall be omitted; and
- in the table, in column No. 4, for the words "six months from the date of commission of any", the words "one month from the date of commission of the first" shall be substituted.

6. Amendment of section 115 of Ordinance XIX of 1965.— In the Ordinance, in section 115:

- in the heading, after the word "permit", the words "or certificate of fitness" shall be added; and
- after the words "may be used", the expression "or without having valid certificate of fitness as required under sub-section (1) of section 39" shall be inserted.

7. Amendment of FIRST SCHEDULE of Ordinance XIX of 1965.— In the Ordinance, in FIRST SCHEDULE, in FORM I, after the words "MOTOR CARS", the expression "MOTOR CYCLES" shall be inserted.

8. Amendment of FIFTEENTH SCHEDULE of Ordinance XIX of 1965.— In the Ordinance, in FIFTEENTH SCHEDULE:

- in the heading, after the words "MOTOR CARS", the words "AND MOTOR CYCLES" shall be inserted; and
- after Serial No.1, the following shall be added:

"2.	Motor cycle	All CC	One year after the date of manufacture	One year".
