**NOTIFICATION**

PTA/TA-I/2025/909(PVICS)(Fee). In pursuance of the approval accorded by the Punjab Provincial Transport Authority in its 07/2025 meeting held on 11.11.2025. The Authority unanimously decided to adopt the EPA's notified schedule of fees for testing of vehicular emission. Therefore, the following schedule of fee is hereby notified as chargeable for inspection of Private Motor Cars to conduct emission testing with immediate effect:

**Cars / Light Transport Vehicles (LTVs)**

Sr. No.	Category of vehicle	Fee (PKR)
1.	1000 CC and below	500
2.	1000 CC to 1500 CC	800
3.	1500 CC to 2500 CC	1,000
4.	2500 CC to 4500 CC	1,500
5.	4500 CC or Higher	2,000

2. The aforesaid schedule of fee shall be charged at the time of emission testing by the Vehicle Emission Testing Center which are granted license by Punjab Provincial Transport Authority under Rule 35-A of the Punjab Motor Vehicles Rules, 1969.


