- Technical bids will be opened on the same day at 01:30 pm on (EPADS) in the presence of the Procurement Committee and representative of the firm.
- Estimated cost of the tender is Rs. 10,274,448 /-.
- Bid security is Rs. 205,489/-.
- The original bid security @2% of estimated price in the shape of Demand Draft / Pay Order / Call Deposit Receipt (CDR) must be submitted to Section Officer (General), Transport & Masstransit Department, Lahore before the closing time and date of tender in the name of Section Officer (General), Transport & Masstransit Department, Lahore.
- Transport & Masstransit Department, Lahore will not be responsible for any cost or expense incurred by bidders in relation to the preparation or electronic submission of bids.
- No telephonic / conditional tender and without earnest money will be entertained.
- All assessments and procurement procedures, including uploading on (EPADS), downloading/receiving, opening, evaluating, and awarding, shall be governed by the Punjab Procurement Rules-2014. In case of any conflict between the bidding documents and the PPRA Rules 2014, the rules shall prevail.
