PTC intends to hire the services from renowned and well reputed Consulting Firm(s), to conduct Short Consultancy titled "Hiring of Short Consultancy Firm for Procurement and Contracts Management" under section 46(A) of Punjab Procurement Regulatory Authority (PPRA) Rules, 2014 amended from time to time. Consulting firms may associate or form joint venture with other firms as per PPRA Rules (amended from time to time).

The proposals shall be opened at 11:30am on the same day in the presence of the applicants/bidders or their representatives who may choose to be present.
