SO(TR-I)2-5/2018(P-XI)(VICS) In exercise of the powers conferred upon him under Section 43 read with Section 69 of the Provincial Motor Vehicles Ordinance, 1965, the Governor of the Punjab is pleased to direct that in partial modification of this Department's Notification No.SO(TR-I)2-5/2016 dated 05th Sep,2017 the following Fee Schedule is hereby notified as chargeable for inspection of Transport Vehicles and grant of Certificate of Fitness thereof under the amended and revised Provincial Motor Vehicles Rules, 1969 notified vide Gazette Notification of even No. dated 15th July,2016:-

a) The Inspection Fee for the grant of Certificate of Fitness shall be as follow:-

Sr. No.	Category of Vehicles	Existing Fee 2017-18 (PKR)	Revised Fee 2018-19 (PKR)
1.	Transport Vehicle Except Delivery Van	1125	1169
2.	Delivery Van	750	779
3.	Motor Cab, Taxi, Rickshaw and Motorcycle Rickshaw	750	779

b) The Fee for the Renewal of the Certificate of Inspection, after every six months, shall be as follow:-

Sr. No.	Category of Vehicles	Existing Fee 2017-18 (PKR)	Revised Fee 2018-19 (PKR)
1.	Heavy Transport Vehicle	563	585
2.	Light Transport Vehicle	563	585
3.	Delivery Van	469	487
4.	Motor Cab, Taxi, Rickshaw and Motorcycle Rickshaw	469	487

c) The Time and Fee for re-inspection of a Transport Vehicle shall be as follow:-

Visit	Time Limit	Fee (PKR)
First re-inspection	Up to 2 weeks after the inspection	No fee shall be charged for the first re-inspection
Second re-inspection	Up to 2 weeks after the inspection	25% of the inspection fee
Third re-inspection	Up to 2 weeks after the inspection	50% of the inspection fee
