- vi. To compile and publish six monthly district report for the perusal of all concerned at the local, divisional and provincial levels;
- vii. To ensure compliance of the Provincial Motor Vehicles Ordinance 1965, the Punjab Road Safety Act 2023 and other stipulations (laws & rules) so that passenger's safety is ensured and enhanced; and
- viii. To carry out any other task as assigned by the Government / Transport Department.
