SO(TR-I)2-5/2020(VICS)(Fee): In exercise of the powers conferred under Section 43 of the Provincial Motor Vehicles Ordinance, 1965 (XIX of 1965) read with rules 3 and 35 of the Punjab Motor Vehicles Rules, 1969 and in supersession of this Department's earlier Notification No.SO(TR-I)2-5/2018(VICS)(P-XI) dated 3rd October, 2019, the Governor of the Punjab is pleased to notify **Vehicle Inspection Fee** for the Grant, Renewal and Re-Inspection for issuance of Vehicle Fitness Certificate, with immediate effect, as follows:


